1. A non-refundable deposit by credit card is required to secure the limousine for service. Signature on this contract constitutes agreement that signor assumes all responsibility for payment of billed amount including any fees assessed as described in this contract.
2. All passengers and signors of this agreement shall be held responsible for any damage done to the vehicle as a result of intentional, reckless or negligent conduct of any passenger. You will be held liable for damage or extraordinary clean up expenses caused or incurred with respect to the interior of the passenger compartment. **FEES ARE AS FOLLOWS:**

Vomiting = \$300 (THREE HUNDRED DOLLARS) per occurrence.

Broken Glassware = \$20 (TWENTY DOLLARS) per broken piece.

Excessive Cleanup Charge (defined as spills, stains, trash on the floor, on bar or in beverage wells) = \$50 (FIFTY DOLLARS).

In the event the client or any one of his/her guests, either by intention or act, cause damage to the limousine or it's contents (i.e., broken TV, scratches in window tint, etc), the client shall be responsible for compensation to Aficionado Limousine for the repairs and/or cost of replacement up to the value of such repair or cost of replacement.

3. **ALCOHOL MAY BE CONSUMED PROVIDED ALL OCCUPANTS ARE OVER THE AGE OF 21.** The chauffeur will make age verification if alcohol is being consumed inside the limousine. Your use of our limousine(s) will be in accordance with all federal, state and local laws, and we may terminate the service immediately without liability if in the sole judgment of the chauffeur and underage drinking violation has taken place or is taking place.

4. **We do not permit smoking in our limousines.** Failure to comply is a \$100.00 (ONE HUNDRED DOLLARS) fine to be paid immediately or charter will be terminated without refund.

5. Aficionado Limousine reserves the right to refuse to transport a person or persons under the influence of intoxicating liquor or drugs, or who is incapable of taking care of themselves, or who shows conduct which is such, or is likely to be such, as to make themselves objectionable to other passengers. Any illegal activity will result in termination of the charter immediately, without refund.

6. For your safety, ALL BODY PARTS must remain inside of the passenger cabin while in the vehicle **at all times** (NO STANDING OR HANGING OUT OF THE WINDOWS). The chauffeur reserves the right to avoid entering any area deemed hazardous to the chauffeur, the limousine, or the passengers. Please keep feet off the bars and couches inside the limousine. No "sleeping" or lying down with feet on the couches. Our limousines are not your bedroom. **At no time will the maximum capacity of the limousine be exceeded.**

7. Payment for non-scheduled overtime must be received/billed at start of over-limit period. We do not bill in increments of minutes. If the car goes more than 15 minutes into overtime without payment, services will be terminated. **Unscheduled overtime is charged at a rate of \$65.00 per hour per limousine.** If you need more time please notify us in advance of your event for a lower hourly rate. Please plan your event accordingly and remember our limousines drive slower than your car!

8. We may discontinue the service at any time in the event that you or any person being transported in our limousine(s) is unruly or abusive to our chauffeur(s), without refund. We shall not be liable for circumstances beyond our control including but not limited to weather, road conditions and breakdowns. We reserve the right to cancel this contract prior to service due to weather, other hazardous conditions, or any unforeseen event beyond our control, in which case your deposit will be refunded. We reserve the right to substitute like vehicles in size and/or color in case of unforeseen circumstances.

9. By placing an order with Aficionado Limousine, you agree that you are aware of these terms and conditions and will honor all charges. You agree to inform all passengers/guests inside the limousine of the rules set forth in this contract. You also represent that you are duly authorized to grant Aficionado Limousine authority to bill service charges to your credit card and will be personally responsible for any charges contracted by you.

10. Gratuity was **not** included in your rate. If you are pleased with the services of your chauffeur, feel free to tip extra; the majority of your chauffeur's income is earned from gratuity.

In the event any part of this contract is declared unlawful or unenforceable, the remaining provisions of this agreement shall remain in full force and effect. **I/We have read and agree that all information regarding trip information has been furnished and is accurate. I/ We have read and agree to abide by the terms of this agreement. This agreement has been read and signed on _____.**
