



CONTRACT FOR AIRPORT TRANSFER

1. A **non-refundable deposit of 50%** of your total bill is due at the time of reservation. Deposit by credit card is required to secure a vehicle for service. Signature on this contract constitutes agreement that signor assumes all responsibility for payment of billed amount including any fees assessed as described in this contract. Any damage caused to any vehicle by signor of this agreement or passenger traveling with signor of this agreement shall be charged full replacement cost for part damaged.
2. There are **no stops authorized** for airport services. Any requested stops will be billed at \$35 per stop and each stop shall not exceed 30 minutes in time or another stop shall be charged. Chargeable requested stops may not be available due to scheduling conflicts. You may speak to your chauffeur to verify availability of chargeable stops. There are no exceptions to the stop rule.
3. ***Airport Wait Times:*** Aficionado Limousine will not be held responsible for late flight arrivals. We monitor all incoming flights and make every effort to delay the arrival of your transportation due to flight delays. If a flight is showing as “on time”, our vehicle shall be dispatched to the airport for an on time pickup. Upon arrival to the airport, we will wait a total of forty-five minutes with no charge for wait time. After forty-five minutes, your account shall be billed \$10 per each fifteen minutes of wait time. Wait time also includes any other delay including but not limited to lost luggage, food/restaurant breaks. We will wait 15 minutes for you to locate and/or coordinate any lost luggage or for any other delay after flight has been in an “ARRIVED” status. After fifteen (15) minutes, your account shall be billed \$10 per each fifteen minutes of wait time. Transportation will wait at the airport up to 2 hours incurring charges. After 2 hours, this contract will be canceled and 50% deposit will be forfeited. You will then have to call our office at (518)229-9538 to rebook your ground transportation.

4. **Pick-up & Wait Times:** For return trips to the airport or transfers, it is imperative that you are on time and ready for immediate departure upon arrival of your ground transportation for your return to the airport or transfer. Should a vehicle have to wait for you in order to depart, your account will be charged *\$15 per fifteen minute time period*. For example, you are scheduled for a 10am hotel pickup. You are not seated in your transportation until 10:10am. Your account will be charged \$15 for the wait time. Aficionado Limousine reserves the right to vacate the premises upon arrival if you, the customer, cannot be located. There will be no refund given. It is in the sole discretion of Aficionado Limousine for pickup wait times. Should you not be on time or hold the vehicle for any reason, we reserve the right to depart and you will receive no refund.

5. **We shall not be liable** for circumstances beyond our control including but not limited to weather, road conditions and mechanical malfunctions. We reserve the right to cancel this contract or any portion thereof prior to service due to weather, other hazardous conditions, or any unforeseen event beyond our control, in which case your deposit will be refunded. We reserve the right to substitute like vehicles in size and/or color in case of unforeseen circumstances.

6. **Gratuity:** Driver gratuity was not included in your rate. Please tip your chauffeur 20% of your total bill for their services. Your driver depends on his/her tip for income.

7. By placing an order with Aficionado Limousine, you agree that you are aware of these terms and conditions and will honor all charges. You agree to inform all passengers/guests inside the limousine of the rules set forth in this contract. You also represent that you are duly authorized to grant Aficionado Limousine authority to bill service charges to your credit card and will be personally responsible for any charges contracted by you.

In the event any part of this contract is declared unlawful or unenforceable, the remaining provisions of this agreement shall remain in full force and effect. **I/We have read and agree that all information regarding trip information has been furnished and is accurate. I/ We have read and agree to abide by the terms of this agreement. This agreement has been read and signed on _____ .**
